#### MINUTES

Vice President for Instruction Dr. Barbara Moir called the meeting to order at 2:05 p.m. in the Human Resources Training Room, and welcomed new members and alternates. Members present were Chas Algaier (representing the School of Education), Dr. Jack Angello (representing Professional and Vocational Education), Ed Zehr (representing Arts and Sciences), Jim Holan (representing Arts and Sciences), and Debbie Raumakita (representing Professional and Vocational Education), constituting a quorum. Ed Camacho (representing Professional and Vocational Education), and Kurt Barnes (representing Arts and Sciences) were present as alternates. Vince Riley was present as recorder.

#### 1. Review and adoption of agenda for today's meeting:

**ACTION #1:** It was moved, seconded and unanimously approved to accept the Agenda, without modification.

#### 2. Review and discussion of changes made to BOR Policy and Procedures 3008:

Dr. Moir called the attention of the Council to the BOR Policy and Procedures 3008, which was amended by the BOR in July 1998, while the council was recessed. She noted that several of the amendments approved were at variance with changes suggested by the Council last spring. She recommended that the members study the changes, and take action, if appropriate. Discussion ensued, particularly about the role of the President, the role of alternates, the role of Council's nonvoting student member, the role of the Articulation Coordinator, the role of the "permanent custodian," and the role of the Vice President for Instruction.

**ACTION #2:** Members postponed final action until the next meeting, so that due consideration could be given to the topic.

## **3.** Election of new Chair:

In keeping with NMC Policy, election of a new Academic Council Chair was held among the members.

ACTION #3: Dr. Jack Angello was elected by the members to serve as the new Chair.

## 4. Scheduling of Fall semester meetings:

It was suggested that 1:30 - 3:00 p.m. on non-payday Fridays might be a more convenient meeting time for members.
