b) Alpha numeric standard

Currently the MA 132 course is considered as a two-digit course compared to math courses at other accredited institutions; it is not a transferable course. A suggestion was made to change its alpha numeric to MA 099 or MA 100, so that it would match its contents then a math course that would transfer to other institutions will be created. The council would like input from academic advisors, two of whom will be invited to the next meeting.

c) Declaring majors

The council discussed if students need to complete a certain number of credits or courses before being considered as a major in a field. More discussion when SOE member is present.

- d) Prerequisite, Proficiency and Placement Level The council will continue to use "Placement Level" in reference to English and Math levels in course guides.
