Academic Council Chair Glenn Keaton called the meeting to order at 1:10 pm.

1) Minutes

The January 15, 2004 minutes were accepted without changes.

2) Agenda

The agenda was accepted with the following changes:

Move item d *NDU grading policies* from Other Issues to item a under Old Business. Move item b *Alpha numeric standard – MA132* from Other Issues to item b under Old Business.

#### 3) Old Business

### a) NDU grading policies

Vince Riley informed the council that the history behind giving "credit/no credit" to NDU courses took place as a result of failing grades given to students in the NDU English courses. These students were given "F" grades, because they were not able to meet the required TOEFL exam score yet they met classroom requirements. Administrators at the time decided that students deserved some kind of credit and not a failing grade. So the grading system for NDU courses established then was "credit/no credit".

Question asked, how does an "F" grade in NDU courses affect students' grant or scholarship awards and grade point average. It was mentioned that the CNMI scholarship covers 12 NDU credits and students pay for any NDU credits exceeding this number. Pell grant allows a maximum of 30 NDU credits. The college has a policy which says that grades/credit earned from NDU courses are not be computed into students' GPAs, but at the present time its implementation does not follow this policy. The council would like to discuss this further with Office of Admissions and Records personnel at the next meeting.

## b) Alpha numeric standard – MA132

Glenn reported that 2 out of 3 colleges and 1 out of 3 universities will accept NMC's Intermediate Algebra course. Daisy Villagomez-Bier reported that MA151 Statistics is definitely transferable; whereas, MA 161 College Algebra is questionable. It was decided to keep MA 132 and create another math course that would fall in between MA 132 and MA 161, with the appropriate number and topic so that it will be transferable.

Dr. Bingham presented the changes he made to the course guide. Changes were to include Asian Pacific literature. However, some members did not agree to the changes.

It was recommended to maintain the original purpose of the course and create another course that focuses on the Asian Pacific region only. Glenn recommended for the members to reassess for more discussion at the next meeting.
