3) Old Business

a) NDU grading policy

The council would like a statement written in the NMC catalog that specifically refers to "F" grade in NDU courses and how this affects students' GPAs. This statement will be written in continuation to the "NC" statement already stated in the catalog. For AC review, statement will read: A failing grade of "F" is given when a student's performance in a course has been inadequate, such grade will be included when computing the student's grade point average.

c) Special Needs statement

The council unanimously adopted the following disability statement to be written on all syllabi:

It is your responsibility to notify the instructor if you have a history and record of a disability that is directly stated in the American with Disabilities Act (ADA) and you require modifications, adaptations or assistive technology in order to fulfill the requirements of this course. All reasonable efforts will be made to accommodate your needs.

4) Other Issues

a) Course guide template No new issue.

b) Course guide web template Item tabled.

c) Online course preparation

The council had requested information on the requirements of course guides for online courses. David Rumptz provided handouts and presented WASC's policy on online courses. WASC's policy says that application to WASC is applicable for programs only not individual classes. According to WASC, an on line course must also be taught inclass or face-to-face. Courses cannot be taught 100% online. The policy does not include procedures about contact hours. Instructors must ensure that students are connected and resources are available. WASC also states that online courses must be optional and not a requirement for graduation. WASC's substantive change is for introducing a program that requires 50% or more of change.

If the Languages Department would like to offer an EN101 online course, the department will not need approval from WASC. For the most part, the department will only need to

indicate the online course on the schedule of classes, because there is a face-to-face class of the same course already.

Can students elect to be in-class and online part of the time? This may create a problem. The instructor will have two classes verses one. Can in-class students use supplemental resources on line? Discussion to be continued.
