The CNMI Department of Commerce developed new sets of emergency regulations for foreign students. To be eligible, students must be in a specific program of study to be consistent with the federal system. What we're doing now is to mirror the federal requirements. Mark asked if Lisa can provide more information on this. Velma Sanchez will also be working to make sure students are appropriately tracked in PC.

Mark advocated GE courses without transfer to be available for these students.
