i) SO 230: The AC Vice Chair indicated there may already be a SO 230 social psychology course in place. The course guide was tabled to give Thomas an opportunity to review the other social psychology course guide. *He will present the course guide again at the next AC meeting.* 

### 7) New Business

a) Rationale for BE 111 as a core course: The BE 111 committee has been making changes to the BE 111 course. The course guide has been revised and will be effective Spring 2012.

The four areas of supportive findings to make BE 111 a core course were presented, which included feedback from several staff and instructors. The recommendation from the committee is to make BE 111 a core course on all individualized degree plans (IDPs). Some students, however, are reluctant to take BE 111 and students transferring from other institutions may not need the course. A recommendation was made to invite staff, instructors, and other stakeholders of this issue to an AC meeting to provide additional feedback. This item was, therefore, tabled for further discussion.
